If you fail to provide a completed application or the required materials, you may not be awarded any monies.
- If you are a returning applicant, you must provide a completed application, your current college transcript of grades, and your schedule for the Fall Semester or proof of enrollment at a different school. Once your materials have been submitted, you will receive information on how to schedule your interview that will be conducted by videoconference.
- Awards of scholarship monies will be determined in late July
